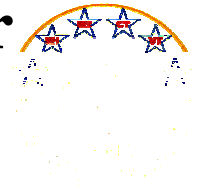

Adult & Minor Amateur Athletic Waiver & Release of Liability

In consideration of being allowed to participate in any way in USA-NKF & NEKA Competitions and related events and activities, the undersigned:

1. Agrees that prior to participating, the participant/and or Parent or Guardian (if under 18), will inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he/she will immediately advise the supervisor of the event or other officials of each condition(s) and refuse to participate.
2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses, which might result not only from their own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us, the participant or not reasonably foreseeable at this time. The participant and/or parent or guardian assumes all the forgoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death.
3. Releases, waives, discharges and covenants not to sue the USA-NKF, NEKA, Christian Karate Academy of Shindo Ryu, Board of Directors of the NEKA, its affiliated clubs, their respective administrators, directors, agents, coaches, and employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
4. I fully understand that any medical treatment given will be of a first aid treatment type only. I Consent that any photographs furnished by me, or any and all photographs or videos images taken of me in connection with the tournament, can be used for publicity, promotion, or television showing now or in the future at the discretion of the NEKA and I waive compensation in regard thereto. All participation in any event or class in this tournament is by permission only. The Director or his authorized agent(s) reserve the right to refuse entry to any person, school, team or club.
